This fund aims to assist low-income families in Singapore to access and achieve home ownership.

THE ISSUE

Today, **out of 1.4 million households in Singapore, about 54,000 families** stay in subsidised rental flats, not owning their own homes. With health and one's living environment being inextricably intertwined, living in public rental housing will often have an impact on the health and mental wellbeing of residents.

OUR PARTNER

South Central Community Family Service Centre (SCCFSC) supports low-income and vulnerable families, giving aid to families who seek help with financial, social or relationship issues. Keystart Home Ownership is a programme managed by SCCFSC and is the first and only community effort in Singapore aimed at empowering and enabling low-income and vulnerable families to achieve their aspirations of owning their dream homes.

Piloted in 2017, Keystart targets low-income families with school-going children or children under the age of 21. These families live in subsidised rental flats, and are motivated to achieve home ownership. Families who encounter additional barriers to achieving home ownership are provided with more support, including single parents, reconstituted (blended) families, families with children born out of wedlock, and transnational families.

Since its inception, **Keystart has aided more than 250 families to successfully secure their own home, in turn benefitting over 600 children.** Of these families, 120 have successfully moved into their new homes. Looking ahead, Keystart aims to extend its support to an additional 1,000 families by 2027.

WHAT YOUR FUNDING COULD UNLOCK

THE BACKGROUND

In the 1970s, the Singapore government introduced the **Home Ownership for the People Scheme to give all citizens a tangible asset and a stake in nation-building**. Home Ownership remains a key national policy in Singapore today and has been a "success story" compared with other global cities with respect to affordability and home ownership.

Rental flats are available at subsidised rates to eligible lowincome Singaporean households. These families **often face numerous challenges that impact their well-being and development**. In Singapore, where housing costs are high and space is limited, families in rental flats usually struggle with overcrowded living conditions.

In rental flats, children may share small living spaces with multiple siblings with no privacy and personal space. This cramped environment can affect their emotional well-being and hinder their physical development, leading to increased incidences of anxiety and depression. Moreover, frequent moves between rental flats can **disrupt a child's education and ability to make lasting social connections, perpetuating a cycle of instability and disadvantage.**
