THE ISSUE

Children everywhere deserve to grow up in loving, safe environments. However, **children living in extreme poverty face unique challenges.**

Poverty creates significant stress for families, making it difficult to provide stable and nurturing environments. This economic hardship **forces families to prioritise survival over education and health, putting children at risk of malnutrition, poor health, and lack of educational opportunities.** This constant struggle can sometimes lead to child abuse and neglect as parents and caregivers face overwhelming pressures. Additionally, children in impoverished situations are at a higher risk of exploitation, trafficking, and mental health issues.

THE ISSUE



Southeast Asia comprises countries with varying levels of economic development, from rapidly industrialising countries like Malaysia and Thailand, to less developed countries such as Cambodia and Laos.

Economic inequality is stark, with many living below the poverty line. Rapid urbanisation has led to megacities, **bringing opportunities as well as challenges like urban poverty, inadequate housing, and limited essential services.** Migration, common within and across borders, often results in children being separated from their families or living in vulnerable conditions as undocumented migrants.

Traditional norms and cultural practices can perpetuate harmful behaviors and discrimination against children, especially girls. There is often a reluctance to report cases of abuse and exploitation due to stigma, fear of reprisal, and lack of awareness about children's rights. The region is also prone to natural disasters such as typhoons, earthquakes, and floods, which exacerbate vulnerabilities. Displacement caused by these disasters also often leads to increased risks of exploitation, trafficking, and disruption of education.

This Impact Fund enables the continued development of work and collaboration between five expert local child protection organisations across Cambodia, Malaysia, the Philippines and Thailand, focusing on areas where children are the most vulnerable.

KEY PRIORITIES



Child Protection support for vulnerable children and victims of abuse:

This focus area is dedicated to creating a secure and nurturing environment for every child, helping them recover and thrive.

This includes immediate protection from threats, temporary shelter to ensure safety, as well as professional emotional support for victims of abandonment, extreme neglect, and severe physical or sexual abuse.

2

Case Management support for children and families:

This area focuses on holistic case management to ensure that each child receives support tailored to his or her unique needs. These can include access to education, healthcare services, and financial assistance, as well as reviews for legal and specialised mental health support.

In this work, a dedicated case manager will journey with the child and family. As part of the case management and development of action plans for the child, families are also involved to ensure that the child gets the care they need to heal, build resilience, and thrive.

3

Outreach and Awareness-building on child rights and protection with key stakeholders:

This focus area is crucial for educating and mobilising the community to identify at-risk children and recognise signs of abuse and neglect. Increased awareness allows more people to detect and report concerns, leading to timely interventions.

These awareness-building efforts also help individuals to learn about available support services and encourages families to seek help before problems escalate.

LOOKING BACK

In 2023, the Fund's partners achieved substantial impact and scalability:

1,500+ vulnerable children and families

received essential child protection and case management services, including counseling, food and hygiene products, educational assistance, medical care, and temporary shelter.

6,500+ children and families

received comprehensive education support, including access to formal and non-formal education, covering enrolment cost, school fees, and essential school supplies.

37,000+ medical and dental treatments

were provided to vulnerable children and their families.

4,200+ children and families

received essential provisions like food, hygiene kits, document assistance, and emergency home repairs.

14,500+ children, youth, and stakeholders, including teachers

participated in training sessions on child rights and protection.

Bangkok and Chiang Mai, Thailand

YEAR FOUNDED 2002

Baan Dek Foundation (BDF) is a Thai-registered foundation with a mission to improve the well-being of vulnerable children and their families living in urban slums and construction site camps across Thailand. To address this challenge, BDF supports children and their parents' immediate needs—such as access to healthcare, education, and child protection services, empowers communities through a peer-to-peer approach—such as through training for youth, adults, and women, and creates systemic change in Thailand's construction sector through its Building Social Impact initiative.

RECENT RECOGNITION

In 2023, BDF won the Japan Social Development Fund Award, which recognises innovative ideas in the implementation of development projects for vulnerable and disadvantaged communities in developing countries.

In 2021, BDF won first place for the Japanese Award for Most Innovative Development Project for 'Access to Healthcare for Migrant Families in the Thai Construction Sector.'

YEAR FOUNDED

M'Lop Tapang (MT) is a Cambodian-registered nonprofit with a mission to provide a safe haven for the vulnerable children of Sihanoukville, offering care and support to any child at risk.

MT offers access to education, reintegration with families, life skills training, as well as creative and recreational activities, while ensuring protection from all forms of abuse. Initially, the focus was on stabilising the crises children face and ensuring safety. Attention then shifted to helping them access opportunities for a better future by targeting the root causes of school dropout, hazardous work, and precarious living conditions. In 2024, MT received a new 3-year MOU with Ministry of Social Affairs, as well as the Department of Education and in 2023, a 5-year MOU with the General Department of Prisons.

RECENT RECOGNITION

In June 2024, MT was awarded a Certificate of Appreciation from the Ministry of Social Affairs, Veterans, and Youth Rehabilitation for 20 years of dedicated service and collaboration in the Sihanoukville region.

MT was also awarded a Certificate of Appreciation from the National Authority of Combating Drugs, describing MT as one of Cambodia's most effective NGOs working in drugs and alcohol support service provision.

YEAR FOUNDED 1990 Stairway Foundation is a Philippine-registered non-profit with a mission to protect and promote children's rights through a variety of intervention strategies developed over more than three decades. Innovation, creative excellence, continuous learning, and the use of technology are core elements in all of Stairway's interventions, including a community assistance programme encompassing educational and medical support, food security, livelihood (including sustainable farming techniques), financial literacy, and a wide range of other community support initiatives: a temporary family home programme offering rehabilitation for particularly disadvantaged children from the streets of Manila, a creative advocacy programme promoting awareness of children's rights, as well as network building and training for key child protection stakeholders across the country.

A comprehensive child rights e-learning platform plays an increasingly important role in child protection work locally, nationally, and internationally.

RECENT RECOGNITION

Stairway Foundation is accredited at the highest level by the Department of Social Welfare and Development for implementing centre-based residential care programmes and services for disadvantaged male children and youth and for community-based programmes for children and youth.

YEAR FOUNDED 1990

Tondo Community Intiative (TCI) is a Philippine-registered nonprofit with a mission to manage and stabilise the immediate and chronic crises faced by children, youth, and families living in Upper Smokey Mountain and the so-called 'Temporary Housing' area of Tondo, Manila.

TCI also works to ensure that children, youth, and families are aware of their rights, the opportunities to access and succeed in education and training, and how they can benefit from welfare and healthcare services available to them. TCI offers a range of support including direct child protection services for very complex child protection cases, enrolment in public schools and alternative learning systems, facilitation of the issuance of birth certificates— essential for enabling access to public services—a medical clinic, and positive activities for youth.

Yayasan Chow Kit (YCK) is a Malaysian-registered non-profit with a mission to protect the rights of all at-risk children and youth, provide them with safe havens, and expose them to as many positive and holistic opportunities as possible to enable them to reach their full potential.

To date, YCK has run two centres: a children's activity centre for children aged 7-12 providing a safe and nurturing environment for the children to learn and play; and a teenagers activity centre for teens aged 13-18 providing a safe space to engage meaningfully and productively with peers.

From August 2024, YCK will move into an improved and expanded multi-floor centre that will integrate both centres into one, improving efficiency and deepening impact. YCK also runs a small safehouse, providing full-time shelter for higher-risk children who are in need of temporary guardianship.

RECENT RECOGNITION

In 2024, YCK was recognised as an 'Integrity Champion' by the Inland Revenue Board of Malaysia.
